As of August 4, 2026, the Company's share price of ₹18.41 per share was significantly lower than the warrant conversion price of ₹50.50 per share. Upon the expiry of the prescribed period for payment of the balance 75% warrant consideration, the warrants lapsed and the upfront subscription amount of ₹30.30 crore was forfeited on July 28, 2026. As a result, after considering the preferential equity issue of ₹89.50 crore, the effective fund raise stands reduced to ₹119.80 crore. The reduction in the overall issue size has consequently increased the proportion of issue proceeds allocated towards General Corporate Purpose, causing it to exceed the 25% limit stipulated under applicable SEBI regulations, thereby resulting in a regulatory breach. The board may take note of the same.	The Preferential Issue size was ₹210.70 crore, of which ₹50.00 crore was allocated towards General Corporate Purposes (GCP), well within the permissible limit of 25% under applicable SEBI regulations. Against this allocation, the Company has utilised only ₹38.30 crore. The observation appears to arise from comparing the GCP utilisation of ₹38.30 crore with the ₹119.80 crore received as of the relevant date. However, at the time of utilisation, the Company was entitled to receive the balance warrant consideration within the stipulated 18-month period, and therefore the approved issue size, and not the amount received as on a particular date, should be the basis for assessing permissible GCP utilisation. Any subsequent forfeiture of warrants, resulting in a lower amount ultimately received, does not retrospectively alter the approved allocation or the utilisation of funds already made in accordance with the objects of the issue. Accordingly, since the GCP utilisation of ₹38.30 crore is within the approved allocation of ₹50.00 crore, the Board is of the view that the utilisation is fully compliant with applicable regulatory requirements and does not constitute any breach or non-compliance.
